THE YOUTH GROW PROGRAM CREATES LIFE-LONG VEGGIE EATERS AND GROWERS THROUGH AFTER-SCHOOL GARDEN CLUBS & SUMMER GARDEN CAMPS. WE CREATE THREE-YEAR PARTNERSHIPS WITH HIGH POVERTY SCHOOLS TO PROVIDE FOOD GARDENING PROGRAMS AND TECHNICAL SUPPORT IN DEVELOPING A SCHOOL GARDEN. IN 2010, 283 ELEMENTARY STUDENTS SPENT 2,210 LEARNING HOURS IN GARDEN CLUB AND GARDEN CAMP. 59 CHILDREN AND 38 ADULTS ATTENDED OUR 9 SUMMER FAMILY ORIENTED WORKSHOPS AND OVER 450 CHILDREN AND 80 ADULTS PARTICIPATED IN SPECIAL ONE-TIME LEARNING OPPORTUNITIES. WE PROVIDE A THREE-YEAR SUPPORT SYSTEM INCLUDING SEEDS, PLANT STARTS, COMPOST BINS, NEWSLETTERS, WORKSHOPS, AND ONE-ON-ONE GARDEN MENTORS. IN 2010, WE INSTALLED 72 NEW HOME GARDENS, REACHING 87 ADULTS AND 82 CHILDREN. WE ALSO PROVIDED SUPPORT TO 128 GARDENERS IN THEIR 2ND AND 3RD YEARS WITH THE PROGRAM.
