SINCE 2006, WE HAVE PARTNERED WITH OVER 20 SCHOOLS TO DESIGN AND IMPLEMENT GARDEN EDUCATION PROGRAMS FOR ELEMENTARY SCHOOL CHILDREN.

WE PARTNER WITH INDIVIDUALS, FAMILIES, AND AFFORDABLE HOUSING DEVELOPMENTS TO BUILD BACKYARD ORGANIC GARDENS AND PROVIDE THREE YEARS OF FREE GARDENING MENTORSHIP, INCLUDING WORKSHOPS, EQUIPMENT AND SUPPLIES, AND SUPPORT IN BUILDING COMMUNITY-BASED LEADERSHIP.
